Team Owners/Managers etc, do not have the authority to allow photographers on the infield for the purpose of doing photos, any request to do this, must be approved by Baron Media or BIS.

There will be a limit of 3 photographers only at any BIS Meeting.

All applications will be treated fairly and any decision is final.

Please attach letter of assignment from approved Media Organisation. Photographers wishing to do "ON SPEC" photos, will not be granted access. All accreditation applications must be for the purpose of reporting or promoting the event. Photographs taken are for the purpose of reporting and promoting the event only. Images obtained from the issue of accreditation are not to be issued for sale or otherwise in any form other than for those that accreditation was granted eg: Magazine, Newspaper etc. No images taken at BIS or from another event or venue may be sold, traded or gifted for commercial purposes either privately, via websites or any other means within the boundaries of Brisbane International Speedway, carparks or such areas used in relation to BIS.

Any breach of these terms will result in action being taken by way of removal from the venue, revoking of accreditation, or both. A safety vest (supplied by you) & accreditation card must be worn at all times while in the pit and infield area. Persons must also abide by any further rules and regulations as required by BIS or Baron Media. All persons issued with accreditation must abide by the terms stated and any contravention of these terms may see your accreditation being revoked and also might prevent you from obtaining accreditation in the future. BIS & Baron Media reserve the right to revoke any accreditation at our discretion for whatever reason.

By signing this application, I also agree that I have the appropriate insurances applicable to my function as required and I wholly indemnify Baron Media & BIS from any and all action arising from any loss or injury, however caused either to myself or a third party.
